In conformity with law, the Tennessee State Board of Equalization has examined and reviewed the 2018 Ad Valorem Assessments certified to the Board by the Comptroller of the Treasury Office of State Assessed Properties on August 31, 2018.

Based on this review, the following Ad Valorem Assessments are hereby certified by the Tennessee State Board of Equalization to the Comptroller of the Treasury Office of State Assessed Properties as the final assessments for tax year 2018, and said assessments are to be distributed to the respective local taxing jurisdictions in accordance with the distribution procedures provided by law. The Board has not completed its review of assessments for the following:

Swift Transportation Co., of Arizona, LLC
TransAm Trucking, Inc.

Hearings or further disposition of these assessments will occur at a later date, and a supplemental certification will be issued thereafter. Please distribute these assessments as originally certified and equalized, and note that the assessments are under appeal.

As provided in our orders issued previously regarding these assessments, the final assessments hereinafter set out, for companies who filed ad valorem reports with the Office of State Assessed Properties, shall be equalized as follows:

1. You are directed to reduce the portion of these nonforced assessments attributable to tangible personal property, by a factor of fifteen percent (15%);

2. You are directed to equalize nonforced assessments (real and personal) by application of the approved appraisal ratios for 2018 (see below), *but not to exceed a factor of 1.0000.*
