COUNT ONE

The Grand Jurors of Maury County, Tennessee, duly impaneled, and sworn upon their oath, present: That DEANNA JONES on or between November, 2017 and January, 2018, in Maury County, Tennessee and before the finding of this indictment, did unlawfully and knowingly obtain or exercise control over property, to-wit: approximately \$1,543.96, of the value of One Thousand Dollars (\$1,000.00) or more but less than Two Thousand Five Hundred Dollars (\$2,500.00), from The City of Spring Hill, without effective consent, with the intent to deprive the said City of Spring Hill thereof, in violation of Tennessee Code Annotated Section 39-14-103, all of which is against the peace and dignity of the State of Tennessee.

COUNT TWO


The Grand Jurors of Maury County, Tennessee, duly impaneled, and sworn upon their oath, present: That DEANNA JONES on or between November, 2017 and January, 2018, in Maury County, Tennessee and before the finding of this indictment, did unlawfully, with the intent to obtain a benefit or to harm another, intentionally or knowingly commit an act relating to the office or employment of DEANNA JONES that constitutes an unauthorized exercise of official power, to-wit: did while acting as an employee of the City of Spring Hill Finance Department, commit a theft by stealing funds from the City of Spring Hill, in violation of Tennessee Code Annotated Section 39-16-402(a)(1), all of which is against the peace and dignity of the State of Tennessee.

COUNT THREE

The Grand Jurors of Maury County, Tennessee, duly impaneled, and sworn upon their oath, present: That DEANNA JONES on or between November, 2017 and January, 2018, in Maury County, Tennessee and before the finding of this indictment, did unlawfully, knowingly, directly or indirectly, access, causes to be accessed, or attempt to access any telephone system, telecommunications facility, computer software, computer program, data, computer, computer system, computer network, or any part thereof, for the purpose of Causing computer output to purposely be false for, but not limited to, the purpose of obtaining money, property, or services for oneself or another, to-wit: approximately \$1,543.96, of the value of One Thousand Dollars (\$1,000.00) or more but less than Two Thousand Five Hundred Dollars (\$2,500.00), by means of false or fraudulent pretenses, representations, or promises, in violation of Tennessee Code Annotated Section 39-14-602(a)(2), all of which is against the peace and dignity of the State of Tennessee.

COUNT FOUR

The Grand Jurors of Maury County, Tennessee, duly impaneled, and sworn upon their oath, present: That DEANNA JONES on or between November, 2017 and January, 2018, in Maury County, Tennessee and before the finding of this indictment, did unlawfully and intentionally destroy, conceal, remove or otherwise impair the verity, legibility or availability of a governmental record, in violation of Tennessee Code Annotated Section 39-16-504(a)(3), all of which is against the peace and dignity of the State of Tennessee.
