**COUNT 1:**

That between the 25th day of March 2018, and the 28<sup>th</sup> day of April, 2018, and in the State and county aforesaid, **SHAY W. PATTERSON** unlawfully and knowingly, by false pretense, without effective consent and with intent to deprive the owner, did obtain or exercise control over the following property of Clarksville-Montgomery County School System: approximately \$1,900.00 in U.S. Currency. Said property had a total value of more than \$1,000.00. Said Defendant acted in violation of TCA 39-14-103, and against the peace and dignity of the State of Tennessee.

PATTERSON** unlawfully and knowingly, by the use of a Visa credit card of the Clarksville-Montgomery County School System, bearing the last four digits 3485, did obtain property with a value of more than \$1,000.00, from Lowes, and other stores, gas stations, service providers and restaurants located in Montgomery County, the said Defendant knowing at the time that the use of the aforesaid credit card was not authorized by the said Clarksville-Montgomery County School System, in violation of TCA 39-14-118, and against the peace and dignity of the State of Tennessee.
