**JOHN RANDOLPH WORRELL**

a continuing theft between the dates of March 1, 2017 and November, 30 2019, in Weakley County, Tennessee, and before the finding of this indictment, did unlawfully, feloniously and knowingly obtain and exercise control over five thousand, four hundred sixty-five dollars and twenty-six cents (\$5,465.26), the property of the City of Martin valued at more than two thousand five hundred dollars (\$2,500) but less than ten thousand dollars (\$10,000), with intent to deprive the owner of property and without the owner's effective consent in violation of T.C.A. §39-14-103, a Class D Felony Theft,

**COUNT TWO**

And the Grand Jurors aforesaid, upon their oaths aforesaid, present further that on the date aforesaid and in the aforesaid County, the aforesaid **JOHN RANDOLPH WORRELL** did unlawfully, feloniously and knowingly use a credit card for the purpose of obtaining services and goods valued at five thousand, four hundred sixty-five dollars and twenty-six cents (\$5,465.26),

with knowledge that the use of the card was unauthorized for these transactions by the City of Martin, in violation of T.C.A. 39-14-118(b), a Class D Felony Fraudulent Use of Credit or Debit Card,

COUNT THREE

And the Grand Jurors aforesaid, upon their oaths aforesaid, present further that on the date aforesaid and in the aforesaid County, the aforesaid **JOHN RANDOLPH WORRELL** did unlawfully, feloniously, knowingly and with intent to obtain a benefit receive a benefit, while a public servant, not otherwise authorized by law, to wit: used the City of Martin Credit Card to make purchases and obtain monthly phone services, in violation of T.C.A. §39-16-402(a)(5), a Class E felony Official Misconduct,

all of which is against the peace and dignity of the State of Tennessee.
