The Grand Jurors of Cheatham County, Tennessee, duly impaneled and sworn, upon their oaths, do present that on or about April 01 through April 30, 2020, in Cheatham County, Tennessee, and prior to the finding of this Presentment, **STEVE D. ALLEN** then and there, being a public servant with the intent to obtain a benefit or to harm another, did unlawfully, feloniously, intentionally or knowingly: received a benefit not authorized by law by use of the city lawn mower for personal use in violation of T.C.A. 39-16-402(1), a Class E Felony, and against the peace and dignity of the State of Tennessee.


COUNT TWO:

The Grand Jurors of Cheatham County, Tennessee, duly impaneled and sworn, upon their oaths, do present that on or about August 23, 2021, in Cheatham County, Tennessee, and prior to the finding of this Presentment, **STEVE D. ALLEN** then and there, did unlawfully, being a public servant with the intent to obtain a benefit or to harm another, did unlawfully, feloniously, intentionally or knowingly: received a benefit not authorized by law by authorizing the use of town equipment and personnel to repair personnel property, a lawn mower tire, in violation of T.C.A. 39-16-402(1), a Class E Felony, which is against the peace and dignity of the State of Tennessee.

COUNT THREE:

The Grand Jurors of Cheatham County, Tennessee, duly impaneled and sworn, upon their oaths, do present that between January 1, 2019 and September 30, 2020, in Cheatham County, Tennessee, and prior to the finding of this Presentment, **STEVE D. ALLEN** then and there, did unlawfully, being a public servant with the intent to obtain a benefit or to harm another, did unlawfully, feloniously, intentionally or knowingly: received a benefit not authorized by law by the purchase of personal meals using the

Town of Ashland City issued credit card in violation of T.C.A. 39-16-402(1), a Class E Felony, which is against the peace and dignity of the State of Tennessee.
