THE GRAND JURORS of Weakley County, Tennessee, duly impaneled and sworn upon their oaths, present that

ANGELA MCELHINEY HUNT

by a continuing theft between the dates of November, 2013 and April, 2019, in Weakley County, Tennessee, and before the finding of this indictment, did unlawfully, feloniously and intentionally obtain utility services from the City of Gleason in the sum of four thousand twenty-five dollars and seventy-three cents (\$4,025.73) valued at two thousand five hundred dollars (\$2,500) or more but less than ten thousand dollars (\$10,000), by deception, fraud, coercion, false pretense and other means to avoid payment for the services, to wit: non payment to the City of Gleason for the utility services, in violation of T.C.A. §39-14-104(1), a Class D Felony Theft of Services,

COUNT TWO

And the Grand Jurors aforesaid, upon their oaths aforesaid, present further that by a continuing theft from November 6, 2020 through November 13, 2020, and in the aforesaid County, the aforesaid **ANGELA MCELHINEY HUNT** did unlawfully, feloniously and

knowingly obtain and exercise control over two thousand five hundred ninety-three dollars and twenty-eight cents (\$2,593.28), i.e. payments made by citizens to the City of Gleason, being the property of the City of Gleason, valued at more than two thousand five hundred dollars (\$2,500) but less than ten thousand dollars (\$10,000), with intent to deprive the owner of property and without the owner's effective consent in violation of T.C.A. §39-14-103, a Class D Felony Theft,

COUNT THREE

And the Grand Jurors aforesaid, upon their oaths aforesaid, present further that by a continuing theft from November 6, 2020 through November 13, 2020, and in the aforesaid County, the aforesaid **ANGELA MCELHINEY HUNT** did unlawfully, feloniously and knowingly obtain and exercise control over five thousand five hundred eight dollars and fifty-two cents (\$5,508.52), the property of the Weakley County Municipal Electric System valued at more than two thousand five hundred dollars (\$2,500) but less than ten thousand dollars (\$10,000), with intent to deprive the owner of property and without the owner's effective consent in violation of T.C.A. §39-14-103, a Class D Felony Theft,

COUNT FOUR

And the Grand Jurors aforesaid, upon their oaths aforesaid, present further that between the dates of November, 2013, through April, 2019, and in the aforesaid County, the aforesaid **ANGELA MCELHINEY HUNT** did unlawfully, feloniously, knowingly and with intent to obtain a benefit, receive a benefit, while a public servant, not otherwise authorized by law, to wit: not paying her City of Gleason water bill in the total amount of four thousand, twenty-five dollars and seventy-three cents, (\$4,025.73) and concealing the continuing theft, in violation of T.C.A. §39-16-402(a)(5), a Class E felony Official Misconduct,


COUNT FIVE

And the Grand Jurors aforesaid, upon their oaths aforesaid, present further that between the dates of November 6, 2020 through November 13, 2020, and in the aforesaid County, the aforesaid **ANGELA MCELHINEY HUNT** did unlawfully, feloniously, knowingly and with intent to receive a benefit not authorized by law, to wit: exercised control over and misappropriated funds in the amount of five thousand, five hundred eight dollars and fifty-two cents (\$5,508.52) paid to the City of Gleason and the Weakley County Municipal Electric System, in violation of T.C.A. §39-16-402(a)(1), a Class E felony Official Misconduct,

COUNT SIX

And the Grand Jurors aforesaid, upon their oaths aforesaid, present further that between the dates of November 6, 2020 through November 13, 2020, and in the aforesaid County, the aforesaid **ANGELA MCELHINEY HUNT** did unlawfully, feloniously, knowingly and with intent to receive a benefit not authorized by law, to wit: exercised control over and misappropriated funds in the amount of two thousand five hundred ninety-three dollars and twenty-eight cents (\$2,593.28), paid to the City of Gleason, in violation of T.C.A. §39-16-402(a)(1), a Class E felony Official Misconduct,

all of which is against the peace and dignity of the State of Tennessee.
