The Grand Jurors for the State of Tennessee, upon their oaths, present that **ANGELA WILLS DICKENS**, a period of time beginning July, 2014 and continuing through May, 2018, in the State and County aforesaid, did commit the offense of theft of property by knowingly obtaining or exercising control over property, to wit; monies totaling approximately \$3,674.00, valued in the amount of two thousand five hundred dollars (\$2,500.00) or more, but less than ten thousand dollars (\$10,000.00) the property of A.C.T.I.O.N Coalition, without the owner's effective consent and with the intent to deprive the owner thereof; a class D felony, in violation of Section 39-14-103 of the Tennessee Code Annotated, and against the peace and dignity of the State of Tennessee.
