THE GRAND JURORS of Crockett County, Tennessee, duly empaneled and sworn, upon their oaths, present that **MICHELLE ANN SPRAGGINS** on or about May of 2013 through April of 2024, in Crockett County, Tennessee, and before the finding of this indictment, did knowingly obtain or exercise control over property, over the value of \$60,000.00, of Crockett County, without their consent, with intent to deprive the said owner thereof, in violation of T.C.A. 39-14-103, all of which is against the peace and dignity of the State of Tennessee;

COUNT TWO

And the Grand Jurors aforesaid, upon their oath aforesaid, present further that **MICHELLE ANN SPRAGGINS** on or about May of 2013 through April of 2024, and in the aforesaid county, and within said jurisdiction, and before the finding of this indictment, did forge a writing with intent to defraud or harm another of sixty thousand dollars (\$60,000) or more but less than two hundred and fifty thousand dollars (\$250,000) in violation of T.C.A. Section 39-14-114, all of which is against the peace and dignity of the State of Tennessee;

COUNT THREE

And the Grand Jurors aforesaid, upon their oath aforesaid, present further that **MICHELLE ANN SPRAGGINS** on or about May of 2013 through April of 2024, and in the aforesaid county, and within said jurisdiction, and before the finding of this indictment, did knowingly use or allow to be used, a credit/debit card issued to Crockett County for the purpose of obtaining property, credit, services or anything else of value in an amount over \$60,000, knowing that for any other reason the use of the card is unauthorized by either the issuer or the person to whom the credit or debit card is issued, in violation of T.C.A. 39-14-118(b), all of which is against the peace and dignity of the State of Tennessee;

COUNT FOUR

And the Grand Jurors aforesaid, upon their oath aforesaid, present further that **MICHELLE ANN SPRAGGINS** on or about May of 2013 through April of 2024, and in the aforesaid county, and within said jurisdiction, and before the finding of this indictment, while a public servant of Crockett County, to wit: with intent to obtain a benefit or to harm another, did intentionally or knowingly receives any benefit not otherwise authorized by law, in violation of T.C.A. 39-16-402(a)(5), all of which is against the peace and dignity of the State of Tennessee.
