COUNT 1

The Grand Jurors for the State of Tennessee, duly elected, impaneled, sworn, and charged to inquire in and for the body of the County of Fentress, in the State of Tennessee, upon their oath, present: That

**MARK ADAM CRABTREE**

prior to the finding of this indictment, on or about January 30, 2023 - December 15, 2023, in the County and State aforesaid, did unlawfully, feloniously, and knowingly obtain or exercise control over the property of the Fentress County Rescue Squad, to wit: U.S. currency, a value of an amount of ten-thousand (\$10,000) dollars or more but less than sixty- thousand (\$60,000) dollars, with the intent to deprive the owner thereof and without the owner's effective consent, in violation of T.C.A. §39-14-103, and against the peace and dignity of the State of Tennessee.

COUNT 2

And the Grand Jurors aforesaid, upon their oaths aforesaid, do further present: That **MARK ADAM CRABTREE** prior to the finding of this indictment, on or about July 11, 2023 - October 30, 2023, in the County and State aforesaid, did unlawfully, feloniously and knowingly forge seven (7) checks purporting to be the act of Mary F. "Frances" Kelly and the Fentress County Rescue Squad, who did not authorize the act, in addition thereto, **MARK ADAM CRABTREE** forged writings on said checks by entering false information on the check memo lines, all with the intent to defraud or harm the Fentress County Rescue Squad and Union Bank, in the amount of eleven thousand seven-hundred (\$11,700.00) dollars, in violation of T.C.A. §39-14-114, and against the peace and dignity of the State of Tennessee.

COUNT 3

And the Grand Jurors aforesaid, upon their oaths aforesaid, do further present: That **MARK ADAM CRABTREE** prior to the finding of this indictment, on or about March 28, 2023 - December 15, 2023, in the County and State aforesaid, did unlawfully, feloniously, and knowingly use a credit or debit card(s) without the effective consent of the Fentress County Rescue Squad for the purpose of obtaining property, credit, services, or anything else of value, to wit: by making personal purchases, a value of an amount of more than one-thousand (\$1,000) dollars, but less than two-thousand five hundred (\$2,500) dollars, with knowledge that such use of the card(s) was unauthorized, in violation of T.C.A. §39-14-118, and against the peace and dignity of the State of Tennessee.

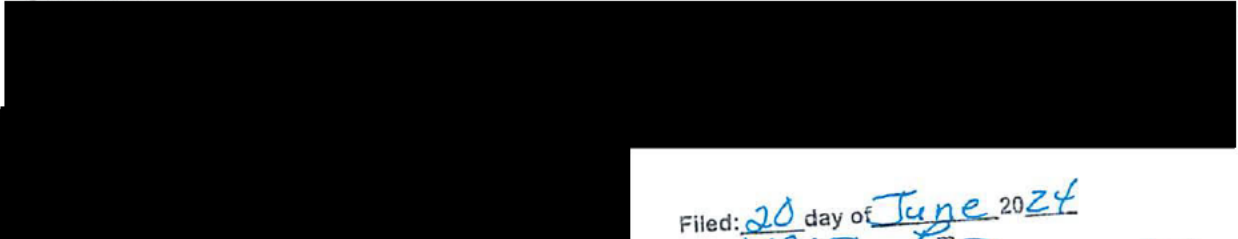
