

SECOND ORDER APPOINTING DISTRICT ATTORNEY GENERAL PRO TEM

On October 3, 2022, this Honorable Court entered an Order allowing District Attorney General, Frederick Agee, and his office voluntarily recuse due to conflict in the above-styled matter and appointing a pro tempore District Attorney General. The Order entered on October 3, 2022, appointed District Attorney General Kim R. Helper of the Twenty-First Judicial District to handle this matter. In March 2023, District Attorney General Kim R. Helper passed away unexpectedly. In May 2023, Stacey B. Edmonson was appointed District Attorney General of the Twenty-First Judicial District. General Edmonson was employed as the Deputy District Attorney General under General Helper's tenure and was originally assigned by General Helper to handle the above-styled matter.

The Office of the District Attorney General for the Twenty-First Judicial District was appointed by the Executive Director of the Tennessee District Attorneys General Conference and District Attorney General Stacey B. Edmonson still accepts this appointment as District Attorney General pro tempore pursuant to the previous appointment.

It is therefore ORDERED, ADJUDGED, and DECREED that the Office of the District Attorney General for the Twenty-First Judicial District, and District Attorney General, Stacey B. Edmonson, and/or her assigned assistant district attorneys, are hereby appointed as the District Attorney General Pro Tempore in this matter for the purpose of conducting a specific criminal investigative and prosecutorial functions of the Gibson County Sheriff's Department's work



between the 1st day of July, 2021 and the 31st day of October, 2022, in Davidson County, Tennessee and before the finding of this indictment, did intentionally or knowingly forge a writing described or depicted as follows: **entries in The Tennessee Offender Management Information System**, of the value of **\$60,000 or more but less than \$250,000**, with the intent to defraud or harm another, to wit: **The State of Tennessee**, in violation of Tennessee Code Annotated §39-14-114, and against the peace and dignity of the State of Tennessee.

**COUNT 2**

THE GRAND JURORS of Davidson County, Tennessee, duly impaneled and sworn, upon their oath, present that:

**PAUL THOMAS**

between the **1st** day of **July, 2021**, and the **31st** day of **October, 2022**, in Davidson County, Tennessee and before the finding of this indictment, knowingly accessed, caused to be accessed, or attempted to access, directly or indirectly, any telephone system, telecommunications facility, computer software, computer program, data, computer, computer system, computer network or any part thereof, the property of another, for the purpose of obtaining money, property or services for **himself** or another, with the value of **\$60,000 or more but less than \$250,000** by means of false or fraudulent pretenses, representations, or promises, in violation of Tennessee Code Annotated §39-14-602, and against the peace and dignity of the State of Tennessee.


