The Grand Jurors for the State of Tennessee, upon their oaths, present that **DMITRY ALEXANDER GROESBECK**, between July 1, 2023 to August 1, 2023, in the State and County aforesaid, did unlawfully commit the offense of theft of property by knowingly obtaining or exercising control over property, to wit; money valued in the amount of ten thousand dollars (\$10,000.00) or more, but less than sixty thousand dollars (\$60,000.00) the property of Doe Mountain Recreation Authority without the owner's effective consent and with the intent to deprive the owner thereof; a class C felony, in violation of Section 39-14-103 of the Tennessee Code Annotated, and against the peace and dignity of the State of Tennessee.

COUNT TWO

CHARGE: OFFICIAL MISCONDUCT

And the same Grand Jurors aforesaid, upon their oaths, do further present that **DMITRY ALEXANDER GROESBECK**, between July 1, 2023 to August 1, 2023, in the State and County aforesaid, did unlawfully commit the offense of official misconduct by being a public servant and intentionally or knowingly with the intent to obtain a benefit or harm another committing an act relating to his employment that constitutes an unauthorized exercise of official power a class E felony, in violation of Section 39-16-402 of the Tennessee Code Annotated, and against the peace and dignity of the State of Tennessee
