COUNT TWO:

And the Grand Jurors do further find that on, between, during and including August 01, 2011 and December 31, 2023, in Humphreys County, Tennessee **AMY S. ANGLEA** did unlawfully and knowing forge a writing with intent to defraud or harm another, in violation of T.C.A. 39-14-114, a Class A Felony, all of which is against the peace and dignity of the State of Tennessee.

COUNT THREE:

And the Grand Jurors do find that on, between, during and including August 01, 2011 and December 31, 2023, in Humphreys County, Tennessee **AMY S. ANGLEA** did unlawfully, intentionally and knowingly make a false entry, or false alteration of, a governmental record; or make, present, or use any record, document or thing with knowledge of its falsity and with intent that it will be taken as a genuine governmental record, in violation of T.C.A. 39-16-504, all of which is against the peace and dignity of the State of Tennessee.

COUNT FOUR:

And the Grand Jurors do further find that on, between, during and including August 01, 2011 and December 31, 2023, in Humphreys County, Tennessee **AMY S. ANGLEA** did commit the offense of identity theft by knowingly the personal identification information of her husband, with the intent to commit any unlawful act and without the consent of such other person; in violation of T.C.A. 39-14-150, a Class D Felony, all of which is against the peace and dignity of the State of Tennessee.
