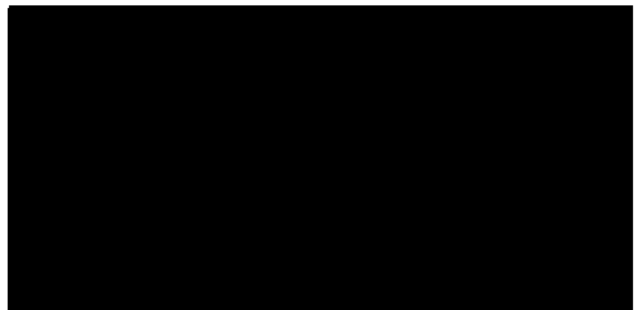

## Count 4:

THE GRAND JURORS of Dekalb County, Tennessee, duly empaneled and sworn upon their oath present that **MEGAN LEANNE MOSLEY** heretofore on the 19<sup>th</sup> day of August, 2025, in Dekalb County, Tennessee and before the finding of this indictment did unlawfully and with intent to defraud Dekalb County Band Boosters, by making false entries in books or records, in violation of T.C.A. §39-14-114, and against the peace and dignity of the State of Tennessee.
