MITCHELL** between January 1, 2007 and June 30, 2009, in Tipton County, Tennessee, and before the finding of this indictment, did unlawfully and knowingly exercise control over property, to-wit: **Cash**, a more particular description thereof being to the Grand Jurors unknown, valued at more than Sixty Thousand Dollars (\$60,000), belonging to the Town of Mason and without effective consent, with the intent to deprive said Town of Mason thereof, in violation of T.C.A. 39-14-103, against the peace and dignity of the State of Tennessee.

COUNT TWO

And the Grand Jurors on their oath aforesaid further present that in Tipton County between January 1, 2007 and June 30, 2009, before the finding of this indictment, the said **ARNITA M. MITCHELL** did unlawfully, feloniously and with intent to defraud the Town of Mason of a sum greater than Sixty Thousand Dollars (\$60,000) make false entires in books or records for the Town of Mason City Clerk.

The said **ARNITA M. MITCHELL** knowing at the time of the entries of the aforesaid were false and were not authorized by the Town of Mason, in violation of T.C.A. 39-14-114, against the peace and dignity of the State of Tennessee.

COUNT THREE

And the Grand Jurors on their oath aforesaid further present that in Tipton County between January 1, 2007 and June 30, 2009, before the finding of this indictment, the said **ARNITA M. MITCHELL** did unlawfully and knowingly access computers belonging to the Town of Mason for the purpose of causing computer output to be purposely false for the purpose of obtaining money, property or services for herself or another by means of false or fraudulent pretenses or representations, in violation of T.C.A. 39-14-602, against the peace and dignity of the State of Tennessee.

COUNT FOUR

And the Grand Jurors on their oath aforesaid further present that in Tipton County between January 1, 2007 and March 11, 2009, before the finding of this indictment, the said **ARNITA M.
