Incentives Update

Well, it has finally been implemented! The CMFO incentives program is off and running and is available to CMFO students who are municipal employees. We are thankful to the Tennessee legislature for providing the funding for these programs in the most recent budget. It is wonderful to see the CMFO program being recognized for its impact on our governments and the improvements to our municipality's financial management as well as the audit reports. The results are something we can all be proud of for the dedicated efforts made by you to ensure our governments work better.

Eligible program participants that are actively pursuing their CMFO certification or have completed the program after July 1, 2022 will now have access to the reimbursement request and stipend authorization forms within their CMFO Act accounts. If you don't see the incentive program forms, it has been determined that you are not eligible. We have already received several requests for reimbursement; however, many of you have not uploaded the itemized travel expense report signed by your supervisor. The process will be delayed, or your municipality may not receive the reimbursement without the proper documentation uploaded. Another thing important to remember is that



these reimbursement requests should be received within 60 days of taking each course. Thank you for your patience and cooperation during this transition phase of issuing these incentives.

What interested you in the CMFO program?

I went through the second class of the CMFO program in 2012. At the time I had only been working in government for less than 4 years in the city's finance department. Coming from working in the music industry business, I did not have full knowledge of government practices. I saw the CMFO program as a way to learn about all areas and a way to improve my performance in my role.



How has being a CMFO impacted your position?

I believe the training I received under the CMFO program has helped me advance in my career with the city. I have now been here for 14 years and am now serving as the CIP Manager overseeing all Capital Improvement Projects from start to end. There are many roles that are needed to ensure projects are done correctly in accordance with city and state regulations and that they stay within the budgeted costs. As a CMFO, I can apply my knowledge learned from the course to the various roles to achieve the best end goal possible.

What would you say to anyone thinking about participating in the CMFO Program? Do it! You will learn a lot even in the areas you think you already know. There are areas that you think will never apply to your job but I believe eventually, some how, some way, you will use every part of the training. Also, don't throw your study guides and books way – I still refer to mine 10 years later.
