Annual Report on Budgets for Municipal Energy Authorities, Utility Districts, and Water & Wastewater Authorities

Fiscal Year 2024

Tenn. Code Ann. §§ 7-36-113, 7-82-501, 68-221-611, and 68-221-1306 *Tennessee Budget Manual for Local Governments*

OVERVIEW AND SCOPE

The Comptroller's Division of Local Government Finance (LGF) reviews and approves annual operating budgets for Tennessee's 11 municipal energy authorities, 171 utility districts, and 9 water and wastewater authorities. State statute also gives the Comptroller's Office budgetary oversight for regional water and wastewater authorities; however, at the time of this report, there were no incorporated regional water and wastewater authorities. Tennessee energy authorities and water and wastewater authorities operate on a fiscal year end ending June 30th whereas utility districts have fiscal year ends that vary. Prior to the beginning of each fiscal year, each utility must adopt a budget and email it, with other required documents, to LGF within 15 days following adoption. Utility systems operated by local governments are subject to the jurisdiction of the Tennessee Board of Utility Regulation; more information is available online.

The scope of this report is limited to the results of budget reviews for the fiscal year 2024. More information about the Comptroller's budget approval process is available <u>online</u>.

APPROVAL PROCESS

Within 30 days of receipt, the Division of Local Government Finance reviews a budget submission and sends a letter to the governing body of the utility system outlining the results of the review. Those letters are available <u>online</u>. Each budget submission will be approved, conditionally approved, or not approved.

Approved: Budgets are approved when projected revenues and other available funds are sufficient to meet anticipated expenses and produce a statutory increase in net position. An approved budget may still have comments regarding areas that should be addressed in future years.

Conditionally Approved: When budgets are conditionally approved, there is some required action by local officials. Generally, if the condition for approval is not met within a certain timeframe, the budget will not be approved.



Not Approved: Budgets are not approved when a utility has a delinquent budget, a delinquent audit, continued noncompliance issues, or fails to meet conditions for approval.

State legislators have recognized the importance of having an approved budget by passing legislation specifying that when a budget is not approved, the governing body may not issue debt or financing obligations. In the case of an emergency, the Comptroller's Office may waive the requirement of budget approval to allow the utility to enter into emergency financial transactions. See Tenn. 2024 APPROVAL RESULTS



Municipal Energy Authorities – Legislation was passed in 2023 that brought municipal energy authorities under the Comptroller's budgetary oversight. Municipal energy authorities are created from utility systems that were formerly operated by a city or town or county. Fiscal year 2025 will be the initial year authorities come under our budgetary oversight; however, 7 of the 11 the municipal energy authorities voluntarily came under our budget oversight for fiscal year 2024. For those, our reviews resulted in 6 approvals, and 1 conditional approval. After local officials had the opportunity to meet the conditions for approval, the budget approvals increased to 7.

Utility Districts – Budget reviews for fiscal year 2024 resulted in 146 approvals, 9

conditional approvals, and 16 budgets that were not approved. After local officials had the opportunity to meet the conditions for approval, the budget approvals increased to 151 and conditional approvals for continued compliance with directives from the Tennessee Board of Utility Regulation remained at 4.

Water and Wastewater Authorities – Budget reviews for fiscal year 2024, resulted in approvals for all 9 water and wastewater authorities in Tennessee.



Budget Certificates

An important part of our review process is recognizing a job well done. To be effective, a budget should be adopted prior to the beginning of the fiscal year, be based on reliable estimates, be structurally balanced, provide for cash liquidity, allow for adequate reserves, be monitored throughout the year, and be amended, as necessary. The Comptroller's Office has an Annual Budget Certificate program to recognize local officials that adopt budgets meeting the following specific criteria:

- The budget was adopted on or before the fiscal year end;
- The budget was filed with the Division of Local Government Finance within 15 days of adoption;
- No issues of concern were raised during our review of the budget; and
- The utility is not currently under the oversight of the Tennessee Board of Utility Regulation.

We congratulate local officials from the **98** utility districts, **6** water and wastewater authorities, and **5** municipal energy authorities that were awarded a budget certificate for the 2024 fiscal year. UNDERLYING CAUSES FOR DIFFERENT APPROVAL TYPES

Fiscal Year 2024 Budgets Not Approved

Appendix A includes a complete listing of utilities with budgets that were not approved for the fiscal year ending June 30, 2024. Budgets were not approved for the following reasons:

- The utility had a late audit at the time of our review of the budget. Annual audits must be filed with the Comptroller's Division of Local Government Audit within six months after the end of the fiscal year.
- The budget was filed more than two months after the beginning of the fiscal year.
- The budget was not submitted for review.

Fiscal Year 2024 Budgets Conditionally Approved

When a budget submission does not meet basic requirements, the budget is approved conditioned upon action by local officials and cannot be approved until the condition(s) is met. Budgets were conditionally approved for the following general reasons:

- Budget estimates for revenue and expenses were unrealistic.
- The budget projected a statutory decrease in net position.
- Depreciation expense was not based upon a reasonable estimate.
- Depreciation expense was not budgeted.
- The budget was not consistent with generally accepted accounting principles.



- The budget submission was incomplete.
- Issues addressed from prior years were not corrected.
- The utility was under the Tennessee Board of Utility Regulation (TBOUR) and approval was conditioned upon continued compliance with TBOUR directives.

Fiscal Year 2024 Budget Considerations and Recommendations for Future Years

Considerations for the next budget year and recommended best practices are an important part of our annual review of the budget and included the following areas:

- The budget should be adopted by resolution.
- The budget was not adopted prior to the beginning of the fiscal year.
- The budget was not filed with the Comptroller's Office within 15 days of adoption.
- The amount budgeted for interest expense was incorrect.
- The utility was under the oversight of the Tennessee Board of Utility Regulation.
- Contact information for the utility was not included in the cover letter.
- The budget submission was incomplete and omitted required information, such as a cover letter and debt schedule.
- The budget resolution omitted the minimum required information.

To support local utility officials in their budget process and financial planning, we recently published "Better Utility Budgeting and Financial Planning" which is available online.

Fiscal Year 2024 Budgets Conditionally Approved on Continued Compliance with Directives of the Tennessee Board of Utility Regulation (TBOUR)

Utility districts and authorities that received a budget approval conditioned upon continued compliance with directives of TBOUR must first reach out to the Division of Local Government Finance prior to issuing debt. At that time, the division will confirm the utility is complying with TBOUR directives.
