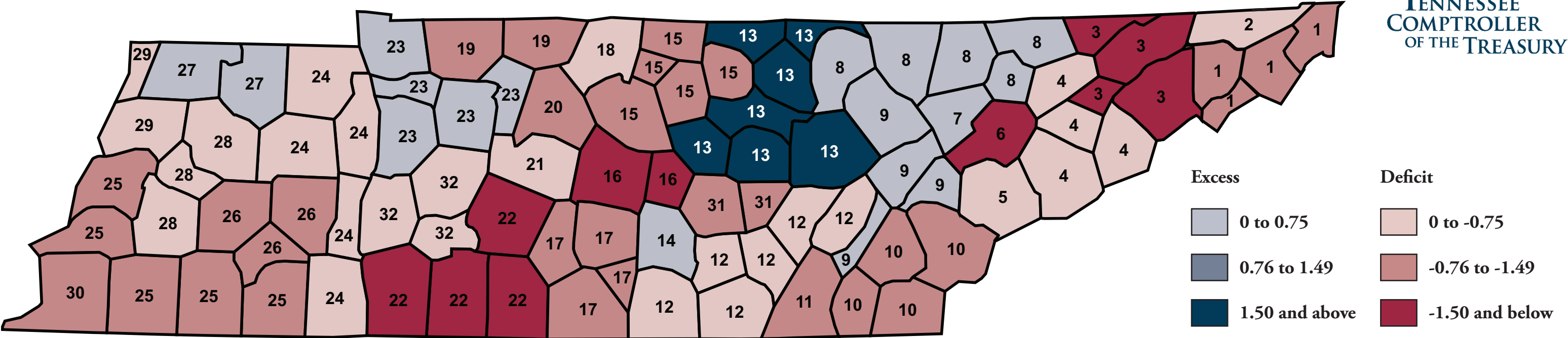


Judicial District (Counties) for Fiscal Year 2025



Judicial weighted caseload studies use case weights and case filings data to determine the amount of judicial resources needed to process a case. A negative value (red) or deficit means the district is understaffed. A positive value (blue) or excess means the district is overstaffed. Judicial resources in this formula include state trial court judges and state-funded child support magistrates.
