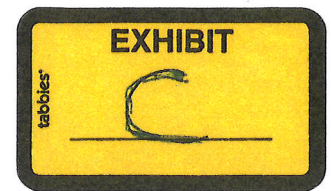

**PRE-HEARING MOTIONS** – Motions raising special or unusual evidentiary or legal issues should be filed as soon as possible so that they can be resolved prior to the hearing. All other pre-hearing motions and briefs shall be filed **no later than February 22, 2019.**

**FILINGS** – All documents filed in this matter shall be filed with the Tennessee State Board of Equalization and must be served on all counsel or other parties included in this matter. Each party must submit one (1) electronic PDF copy and two (2) physical paper copies of all exhibits and witness lists, including identifying index, to the State Board of Equalization at the above referenced address.**

Copies of all witness lists and exhibits shall be made available for viewing to opposing counsel or parties, upon request from a party. Failure to comply may result in exclusion of a witness or exhibit that was not properly disclosed and filed with the Tennessee State Board of Equalization.

**COMPLIANCE** – The parties are cautioned that any failure by either party to “participate in a pre-hearing conference, hearing or other stage” of these proceedings, including compliance with the pre-hearing filing deadlines, may result in that party’s being held in default pursuant to TENN. CODE ANN. § 4-5-309, and this matter being dismissed.
