

Dear Members of the 112th General Assembly,

Over the past year, the Comptroller's Office has worked with the Water & Wastewater Financing Board (WWFB) and the Utility Management Review Board (UMRB) to make utilities work better in almost every legislative district across Tennessee. While each utility is different, they all have the same goal of providing reliable and affordable service to customers. Our Office works to ensure that utilities have rates that are justifiable and reasonable.

As Technical Secretary for the WWFB, I work with my colleague, Ross Colona, to provide financial guidance, as well as technical and managerial assistance, to the 251 municipalities, 14 counties, and 10 treatment authorities that oversee a water and/or wastewater system in Tennessee. We also serve as staff to the UMRB, providing the same guidance and assistance to the 175 utility districts across Tennessee.

I hope this annual report demonstrates some of the successes we have had in the past year and the challenges we face moving forward. The WWFB and UMRB recognize that protecting the financial health of

government utilities also protects public health. I am confident that with your continued support, we will make utilities work better.

New Division

This year, the Comptroller's Office established the Division of Local Government Finance (LGF) to enhance services and support that help make Tennessee's local governments, including government utilities, work better. In addition to providing assistance and guidance to local government utilities on financial issues, LGF enables the Comptroller's Office to provide more in-depth research and information on local government finance matters to the Tennessee General Assembly.

LGF's staff consists of Director Betsy Knotts, Assistant Directors John Greer and Sheila Reed, seven analysts, and one specialist.

SEVEN KEYS TO A FISCALLY WELL-MANAGED GOVERNMENT

LGF has been a valuable resource to Tennessee's utilities throughout the challenges of this year, including the coronavirus pandemic. COVID-19 has brought many uncertainties to Tennessee's local government utilities, and many have had questions about how to continue their financial and operational responsibilities lawfully and effectively this year.

CHALLENGES

Utilities are one of the most important services that government entities provide. The Water & Wastewater Financing Board and the Utility Management Review Board not only recognize the importance of efficient and stable utility systems, but their members also understand the significant challenges, even outside of the pandemic, that many local governments face in maintaining their financial stability.

While most utilities welcome assistance in developing financial plans from our Office, some refuse to accept help or advice. In these situations, the Boards are forced to exercise their statutory authority in issuing orders requiring the utilities to take certain actions necessary for financial success. While these orders are enforceable through chancery court, we are currently involved in only one such instance, and we only use this remedy if all other attempts to help have failed.

In other situations, the Boards initiate and participate in consolidation negotiations between two or more systems that serve the same general area. The Boards only initiate consolidation negotiations when they are convinced it is the best option for long-term viability. These cases often involve utilities located in areas where growth is impossible or unlikely or where the population has declined so significantly that the decreasing customer base can no longer support a utility. Affected customers typically enjoy stability in rates and service after a consolidation occurs.

Many utilities also struggle to navigate the high cost of preserving and replacing aging infrastructure while maintaining reasonable customer rates. Through training and education, the Comptroller's Office proactively helps utilities anticipate these costly investments, plan for the future, and find effective strategies for current maintenance projects.



TRAINING

Thanks to the diligent efforts of the General Assembly, Tennessee is one of the leading states in the nation for utility training requirements. All board members that oversee government water and wastewater systems and natural gas utility districts are now required to have training. Other states are beginning to follow our model because of the success Tennessee utilities and their customers enjoy. We sincerely thank the General Assembly for its support of training and education.

The Comptroller's Office is proud to have successfully developed online training that is available at no cost to members of local utility boards. This virtual training has allowed members of governing bodies to safely meet their continuing education obligations without putting their health at risk.

We believe that by providing free training to the decision makers, giving technical and managerial assistance to the individuals running utilities daily, and building long-term plans for those facing financial distress, we ensure future generations will enjoy the same quality utility service we receive today.
