The Tennessee Local Development Authority will meet on Monday, June 24, 2024, at 2:35 p.m. CT or immediately following the Tennessee State Funding Board meeting, whichever is later, in the Volunteer Conference Center, 2nd Floor, Cordell Hull Building, Nashville. The Authority will receive public comment on actionable agenda items in accordance with 2023 Public Chapter 300 and Board guidelines.

The agenda items for the Tennessee Local Development Authority meeting include:

- Consideration of requests from the City of Humboldt and the Humboldt Utilities Authority:
 - Consider for approval a request to transfer (through the issuance of new SRF loans with the same terms) the City of Humboldt's SRF loans to the Humboldt Utilities Authority and to update the security to the combined revenues of the System
 - Consider for approval a request from Humboldt Utilities Authority to issue Water and Sewer Revenue Bonds in an amount not to exceed \$400,000 on parity with its SRF loans
