TENNESSEE STATE FUNDING BOARD September 7, 2021

The Tennessee State Funding Board (the "Board") met on Tuesday, September 7, 2021, at 2:05 p.m., in the Executive Conference Room, State Capitol, Ground Floor, Nashville, Tennessee. The Honorable Jason Mumpower, Comptroller of the Treasury, was present and presided over the meeting.

The following members were also present:

The Honorable Tre Hargett, Secretary of State The Honorable David Lillard, State Treasurer Commissioner Butch Eley, Department of Finance and Administration

The following member was absent:

The Honorable Bill Lee, Governor

Having established that a quorum was present, Mr. Mumpower called the meeting to order and presented the minutes from the meeting held on July 22, 2021, for consideration and approval. Mr. Hargett made a motion to approve the minutes, and Mr. Lillard seconded the motion. The motion was unanimously approved.

Mr. Mumpower then recognized Mr. Bob Rolfe, Commissioner of the Tennessee Department of Economic and Community Development ("ECD"), to present FastTrack projects for consideration and Mr. Paul VanderMeer, Assistant Commissioner of Administration, ECD, to present the "FastTrack Report to State Funding Board" (the "Report"). Mr. VanderMeer reported that, as of the date of the July 22, 2021, Board meeting, the FastTrack balance was \$393,492,868.59. Since that time, \$343,604.92 in new funds had been appropriated from FastTrack interest recorded by the Department of Finance and Administration ("F&A"), \$12,822,500.00 in new grants and loans had been approved; and \$62,365.92 in funds had been spent on FastTrack administrative expenses, which resulted in an adjusted FastTrack balance available for funding grants and loans of \$380,951,607.59 as of the date of the Report. Mr. VanderMeer reported that commitments had been made in the amount of \$267,721,839.76, resulting in an uncommitted FastTrack balance of \$113,229,767.83. Mr. VanderMeer reported that the projects to be considered at this meeting totaled \$69,600,000.00, and if these projects were approved, the uncommitted balance would be \$43,629,767.83 and the total committed balance would be \$337,321,839.76, which represented 88.5% of the FastTrack balance.

Mr. Mumpower requested, without objection, that the first four FastTrack projects on the agenda be presented together and the final project separately. Mr. Rolfe then presented the following FastTrack projects:

The Board member packets included letters and FastTrack checklists signed by Commissioner Rolfe, and incentive acceptance forms signed by company representatives. Mr. Mumpower inquired if the companies that had signed the incentive acceptance forms fully understood the agreements, and Commissioner Rolfe responded affirmatively. Mr. Mumpower then inquired if the checklists had been completed for each project and Commissioner Rolfe responded affirmatively. Mr. Mumpower then inquired if all the projects included accountability agreements which would provide protections for the state in the event the entity could not fulfill the agreement, and Mr. Rolfe responded affirmatively. Mr. Hargett made a motion to approve the projects. Mr. Lillard seconded the motion, and it was unanimously approved.

Mr. Mumpower then recognized Mr. Rolfe to present the final FastTrack project on the agenda. Mr. Rolfe then presented the following FastTrack project:

Oracle America, Inc. – Nashville (Davidson County)
 FastTrack Economic Development Grant
 \$65,000,000

Mr. Mumpower inquired if the company that had signed the incentive acceptance form fully understood the agreement, and Commissioner Rolfe responded affirmatively. Mr. Mumpower then inquired if the checklist had been completed for the project and Commissioner Rolfe responded affirmatively. Mr. Mumpower then inquired if the project included an accountability agreement which would provide protections for the state in the event the entity could not fulfill the agreement, and Mr. Rolfe responded affirmatively. Mr. Rolfe then made a clarification regarding the letter that the members received in their packets. Mr. Rolfe stated that the letter listed the number of jobs that would be created over a five-year period by the project, however, the negotiated accountability agreement timeframe to be eight (not five) years due to the campus being built in three separate phases.

Mr. Mumpower then asked, if everything were to run smoothly, when would Mr. Rolfe anticipate a groundbreaking. Mr. Rolfe responded no later than the first quarter of 2022 if not sooner. Mr. Eley then inquired if five years was the typical length of an accountability agreement. Mr. Rolfe responded in the affirmative and stated that the Oracle project was given an extended period of time due to the campus being built in three separate phases. Mr. Rolfe further responded that he did not believe the third campus facility would be opened until 2027. Mr. Hargett made a motion to approve the project. Mr. Lillard seconded the motion, and it was unanimously approved.

Mr. Mumpower then recognized Ms. Sandra Thompson, Director of the Division of State Government Finance (SGF) and Assistant Secretary of the Board, to present for consideration and approval a "Resolution Allocating from the Debt Service Fund to the Capital Projects Fund \$1,400,000 and Canceling Authorized Bonds". Ms. Thompson stated that the state was authorized to issue General Obligation ("GO") bonds in the form of commercial paper ("CP") to provide funding for the purpose of acquisition of land for the West Tennessee Megasite and Right of Way, and that it was no longer needed to fund the authorized project. Ms. Thompson further stated that \$1,400,000 was appropriated to repay the CP and that the Commissioner of F&A recommended, in a memorandum dated August 2, 2021, that the Board cancel a

like amount of the unissued GO bonds. Ms. Thompson then stated that the CP outstanding was amortized with a payment made annually. Ms. Thompson then stated that the resolution would be effective on September 7, 2021. Mr. Eley made a motion to approve the resolution. Mr. Lillard seconded the motion, and it was unanimously approved.

Mr. Mumpower then recognized Ms. Thompson to present for consideration and approval a "Resolution from the Debt Service Fund to the Capital Projects Fund \$7,000,000 and Canceling Authorized Bonds". Ms. Thompson stated that the state was authorized to issue its GO bonds in the form of CP to provide funding for the acquisition and implementation of an interoperable communication system upgrade. Ms. Thompson further stated that the Board was appropriated \$7,000,000 to repay the CP and that the Commissioner of F&A recommended, in a memorandum dated August 2, 2021, that the Board cancel a like amount of the unissued GO bonds. Ms. Thompson then stated that the resolution would be effective September 7, 2021. Ms. Thompson pointed out that this was the last amount that remained of the project authorization. Mr. Hargett made a motion to approve the resolution. Mr. Eley seconded the motion, and it was unanimously approved.

After requesting other business and hearing none, Mr. Mumpower made a motion to adjourn the meeting, and Mr. Lillard seconded the motion. The motion was unanimously approved, and the meeting was adjourned.

Dear Comptroller Mumpower:

The Department of Economic & Community Development (the "Department") seeks approval by the State Funding Board (the "Board") pursuant to T.C.A. § 4-3-717(a) authorizing FastTrack infrastructure, training, and economic development grants where there is a commitment by an eligible business to create or retain private sector jobs or engage in private investment or where the Commissioner of Economic and Community Development determines that such investment will have a direct impact on employment and investment opportunities in the future. The following projects meet the statutory requirements, and the Department presents these projects to the Board pursuant to the mandates of T.C.A. § 4-3-717(e), which requires approval of grants and loans under the FastTrack Infrastructure Development Program, the FastTrack Job Training Assistance Program, and the FastTrack Economic Development Program that exceed \$750,000 per eligible business within a three (3) year period.

1. Life Technologies Corporation (Thermo Fisher Scientific Inc.) – Lebanon (Wilson County)

Thermo Fisher is the world leader in serving science. The company serves global customers in the pharmaceutical and biotech sectors, as well as in hospitals and clinical diagnostic labs, universities, research institutions and government agencies.

Thermo Fisher has committed to build a new single-use technology assembly facility, where it will produce bioprocess containers and fluid transfer assemblies that are used globally by biopharma companies to develop and produce therapeutics and vaccines. The positions will focus on manufacturing, assembling and packaging bioprocess containers in a clean room environment with additional roles in engineering, procurement, quality, warehousing and site leadership.

Life Technologies Corporation (Thermo Fisher Scientific Inc.) has committed to create 1,400 net new jobs and make a \$182,755,000 capital investment within five (5) years. The company will have an average hourly wage of \$22.72 for the new positions.

Total FastTrack funds for this project - \$10,500,000

2. IMC Companies and IMC, NA – Collierville (Shelby County)

Family-owned and operated for 40 years, IMC plays an integral role in the international supply chain industry. The company has grown to provide services that include drayage, expedited services, warehousing, chassis provisioning and secured container storage. With more than 2,200 drivers and trucks across the U.S. and industry-expert leadership, IMC pairs regional expertise with nationwide coverage for innovative customer solutions.

Currently located in Memphis, IMC will relocate its headquarters operations to Collierville to support the company's growth. Construction on the 75,000-square-foot Collierville facility is underway and expected to be complete later this year.

IMC Companies and IMC, NA has committed to create 158 net new jobs and make a \$3,350,000 capital investment within five (5) years. The company will have an average hourly wage of \$30.58 for the new positions.

FastTrack Economic Development Grant Funds will help offset expenses such as building expansion, building improvements, fixture improvements, new construction, and lease payments. (\$2,000,000)

Total FastTrack funds for this project - \$2,000,000

3. Smith & Wesson Brands, Inc. – Maryville (Blount County)

Founded in 1852, Smith & Wesson is one of the world's leading manufacturers and designers of firearms. They manufacture a wide array of handguns (including revolvers and pistols), long guns (including modern sporting rifles, bolt action rifles, and shotguns), handcuffs, suppressors, and other firearm-related products for sale to a wide variety of customers, including firearm enthusiasts, collectors, hunters, sportsmen, competitive shooters, individuals desiring home and personal protection, law enforcement and security agencies and officers, and military agencies in the United States and throughout the world.

Smith & Wesson Brands, Inc., the U.S.-based leader in firearms manufacturing and design, will relocate its headquarters and other major operations from Springfield, Massachusetts to Maryville, Tennessee.

In addition to its headquarters, Smith & Wesson will relocate its distribution, assembly, and plastic injection molding operations to Tennessee. Smith & Wesson will locate in Partnership Park North in Blount County, where the company plans to break ground before the end of the year.

Smith & Wesson Brands, Inc. has committed to create 750 net new jobs and make a \$124,521,000 capital investment within five (5) years. The company will have an average hourly wage of \$24.56 for the new positions.

FastTrack Economic Development Grant Funds will help offset expenses such as new construction. (\$9,000,000)

Total FastTrack funds for this project - \$9,000,000

4. Lodge Manufacturing Company – South Pittsburg (Marion County)

Founded in 1896, Lodge is a fifth-generation, family-owned company that manufactures the largest selection of American made cast iron cookware. Lodge operates two foundries in South Pittsburg, the second of which opened in 2017 and increased the company's manufacturing capacity by 75%.

Lodge offers a variety of products ranging from its signature seasoned cast iron to enameled cast iron and carbon steel cookware. Customers can also shop a wide range of items specifically made for grilling or baking.

In order to meet increased demand, Lodge will expand and reconfigure its existing facility and additional manufacturing equipment to enhance production capabilities at their South Pittsburg foundry, where it has operated for more than 125 years.

In 2016, Lodge Manufacturing Company committed to create 158 new jobs with an average wage of \$19.04 per hour and make a \$78,543,031 capital investment. Lodge built a new 127,000 square foot foundry on their South Pittsburg campus and a 200,000 square foot warehouse in New Hope. At that time, TNECD awarded Lodge Manufacturing Company with an Economic Development grant valued at \$790,000 to offset costs incurred to construct the new foundry.

Lodge Manufacturing Company has committed to create 239 new jobs and make a \$55,892,342 capital investment within five years. The company will have an average wage rate of \$23.79 per hour for the new positions.

FastTrack Economic Development Grant funds will be used to offset expenses such as building retrofit, building improvements, building expansion, new construction, and roof improvements. **(\$1,210,000)**

Pursuant to Tennessee Code Annotated §4-3-717 (d)(1)-(2), I am writing to inform you that the Department of Economic and Community Development is awarding a FastTrack Economic Development Grant to the Marion County Industrial and Environmental Development Board for the benefit of Lodge Manufacturing Company in the amount of \$1,210,000 to offset expenses such as building retrofit, building improvements, building expansion, new construction, and roof improvements. The project activities would not be eligible for the FastTrack Infrastructure Development Program.

This project will yield a proportionately significant impact on this rural community due to the number of net new high-wage jobs and significant capital investment. Lodge Manufacturing Company has committed to create 239 new jobs and make a \$55,892,342 capital investment within five years.
