TENNESSEE STATE SCHOOL BOND AUTHORITY NOTICE OF MEETING

The Tennessee State School Bond Authority (TSSBA) will meet on Tuesday, July 25, 2023, at 8:00 a.m., in the House Hearing Room II on the 1st floor of the Cordell Hull Building, Nashville, Tennessee.

At that time, the Authority will receive public comment on actionable agenda items in accordance with 2023 Public Chapter 300 and Board guidelines. The Authority will then consider the following:

 - University of Tennessee, Knoxville – Lindsey Nelson Stadium Renovations (A99); Cost: \$95,800,000 of which \$85,000,000 will be financed from TSSBA; Term of Financing: \$72,500,000 to be financed over 30 years at an assumed taxable rate and \$12,500,000 to be financed over 10 years as short-term financing at an assumed taxable rate
 - University of Tennessee Knoxville – Neyland Stadium South Renovations (A94); Increase in cost of \$49,000,000 for total funding of \$337,000,000 of which \$279,300,000 (includes an increase of \$47,300,000) will be financed by TSSBA; Term of Financing: \$200,200,000 to be financed for 30 years as long-term financing at an assumed tax-exempt rate and \$79,100,000 to be financed over 10 years as short-term financing at an assumed tax-exempt rate
